ARTICLES OF INCORPORATION

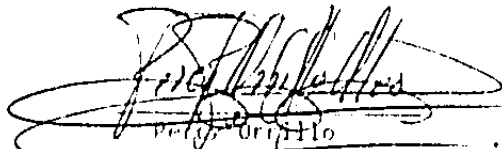

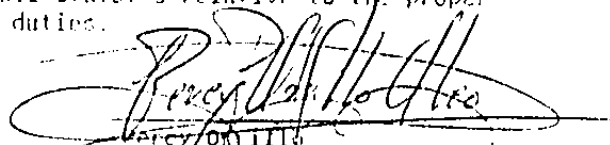
