ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is PENSACOLA NORTH INVESTMENTS, INC., and its principal office is located at 118 West Cervantes Street, Pensacola, Escambia County, Florida 32501.

ARTICLE II

DURATION

INITIAL REGISTERED OFFICE AND AGENT




