ARTICLES OF INCORPORATION OF
SALTWATER CHARTERS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is SALTWATER CHARTERS, INC.

ARTICLE II. DURATION

This corporation shall have a perpetual existence commencing on September 13, 1996, the date of execution hereof.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of Common Stock.

ARTICLE V. PREEMPTIVE STOCK

Stockholders shall have preemptive rights to buy stock except as may otherwise be provided by the Board of Directors.

ARTICLE VI. PRINCIPAL OFFICE,
