The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows.

ARTICLE I

NAME

The name of this corporation is: PREMIUM REAL ENTATE, INC.

ARTICLE II

<u>PURPOSE</u>

The general nature of the business to be transacted by this corporation shall be:

- Alter, manage, and control directly or through ownership of slock in any corporation, any and all kinds of buildings, houses, hotels, bungalows, stores, offices, warehouses, mill, shops, factories, machinery and plants, and any and all structures and erections which may at any time necessary, usoful, or advantageous in the judgment of the Board of Directors, for the purpose of the Corporation, and which can lawfully be done.
