**ARTICLES OF INCORPORATION  
OF  
CANNON, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the Corporation shall be: **CANNON, INC.**

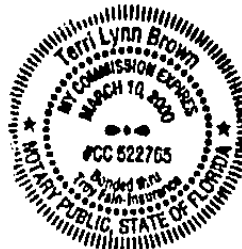
