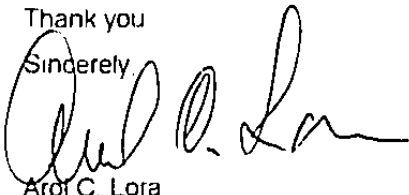

## **ARTICLES OF INCORPORATION**

THE UNDERSIGNED, as proper persons acting as incorporators of a corporation for profit, under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

### **ARTICLE I**

**NAME OF THE CORPORATION.** The name of the Corporation is: Hot and Cold Beverages, Inc.

### **ARTICLE II**

**DURATION OF THE CORPORATION.** The Corporation shall have perpetual existence.

### **ARTICLE III**

**PURPOSE OF THE CORPORATION.** The purpose of the Corporation is to carry out all activities permitted by the laws of the United States, and this state, and the applicable laws of the localities and jurisdictions in which the Corporation conducts business.

### **ARTICLE IV**

**AUTHORIZED STOCK.** The directors of the Corporation are authorized to issue ten thousand (10,000) shares of common stock, no par value.

### **ARTICLE V**

**START OF BUSINESS.** The Corporation will not commence business until at least five hundred (\$500.00) dollars have been received by it as consideration for the issuance of shares.

### **ARTICLE VI**

**ADDRESS OF THE CORPORATION.** The Corporation's address is 1188 Northeast 47th Street -- w24 Oakland Park, FL 33334.

### **ARTICLE VII**

**BOARD OF DIRECTORS.** The Board of Directors of the Corporation shall consist of two directors. The number of directors may be changed from time to time by the stockholders of the corporation through the adoption of resolutions or by-laws.

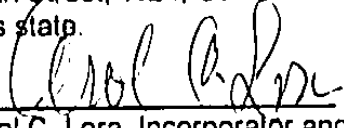

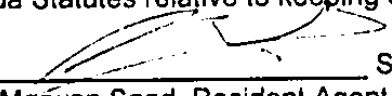
