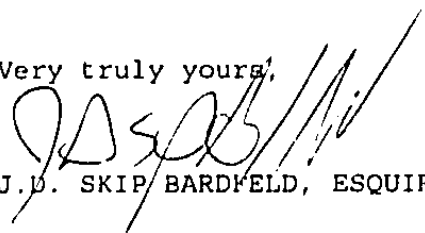

ARTICLES OF INCORPORATION

OF

HEALTH START, INC.

ARTICLE I

The name of the corporation is Health Start, Inc.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated, pursuant to Chapter 607, Florida Statutes, known as the Florida General Corporation Act.

ARTICLE IV

The corporation is authorized to issue Five Hundred (500) shares of capital stock at the par value of \$1.00 each.

ARTICLE V

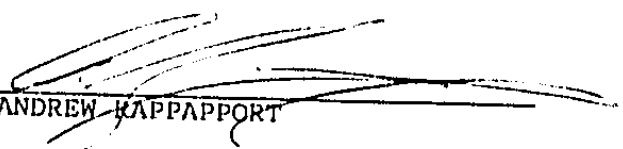
