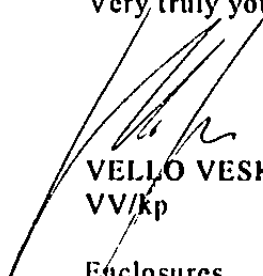

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares, all of one class, ONE (\$1.00) DOLLAR par value.

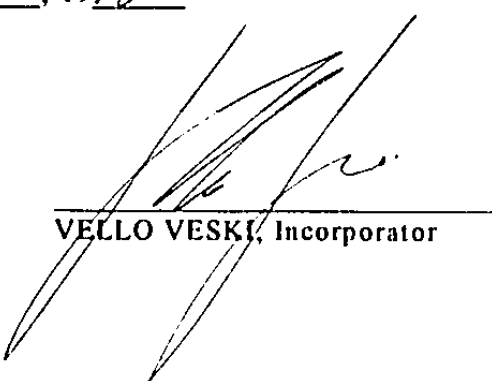

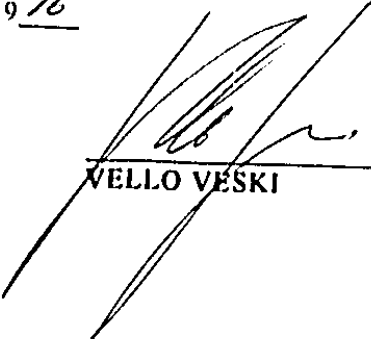
