# PCI MAIL SERVICES, INC. ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General? Corporation Act, adopt the following articles of incorporation for such corporation:

#### 1. NAME:

The name of the corporation is PCI Mail Services, Inc.

### 2. PERIOD:

The period of its duration is perpetual unless sooner dissolved.

#### 3. PURPOSE:

The general purpose of purposes for which the corporation is organized are to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act; and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

## 4. CORPORATE POWERS:

The corporation shall have all powers conferred upon it by law, particularly under F.S. 607.011, except such powers as are inconsistent with the express provisions of these articles. The above enumerated authority shall not be construed as limiting or restricting the authority of this corporation. The corporation specifically reserves the right to amend, add to, or repeal a provision contained in these articles of incorporation, in a manner consistent with the provisions set forth in the bylaws.

## 5. AUTHORIZED SHARES:

The aggregate number of shares that the corporation shall have the authority to issue is 100 shares of Capital stock with a par value of one dollar (\$1.00) per share.

**Right of Conveyance**: Holders of issued shares of the corporation shall have no right to sell, deed, will or otherwise convey said shares except as may be stated in separate devices executed by authorized agents of the corporation.

Initial issue: 100 shares of the Capital Stock of the corporation shall be issued for cash at a par value of \$1.00 per share.

Stated capital: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

**Dividends**: The holders of the outstanding capital stock shall be entitled to receive, then and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

No classes of stock: The shares of the corporation are not to be divided into classes.

### 5. CAPITAL STRUCTURE: C CORPORATION:

The corporation is authorized to issue only one class of stock.

#### 6. REGISTERED AND PRINCIPAL ADDRESS:

The address of its initial registered office is 5730 Corporate Way, Suite 214, West Palm Beach, FL 33407, and the name of its initial registered agent at said address in Richard M. Johnston. The principal office and registered office shall be at the same location.


