ARTICLES OF INCORPORATION

OF

ATLANTIC SOUTH ELECTRIC, INC.

ARTICLE I

CORPORATION NAME

The name of the Corporation is ATLANTIC SOUTH ELECTRIC, INC.,

ARTICLE II

PURPOSE
