ARTICLES OF INCORPORATION

OF:

The undersigned natural person, having capacity to contract and acting as the Incorporator of this Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for such Corporation, to-wit:

ARTICLE ONE: NAME AND PRINCIPAL OFFICE

The name of the corporation is: FEDERAL ESTATE BUYERS, INC.

The address of its principal office is: 4215 Tranquility Drive, Highland Beach, Florida 33487.

ARTICLE TWO: COMMENCEMENT AND DURATION
