## Articles of Incorporation

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. Name & Address. The name of this corporation is, Pelican Pools and Spas, Inc. 16206 Fantasia Drive, Tampa, Fl. 33624
2. Duration. The period of its duration is perpetual.
3. Purpose. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. Capital Stock. The corporation is authorized to issue 500 shares, all of one class, at \$1.00 par value.
5. Initial registered office and agent. The name and address of the initial registered agent and office of the corporation is as follows;

6. Initial Board of Directors. This corporation shall have one (1) director initially. If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

11. Amendment of Articles. This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

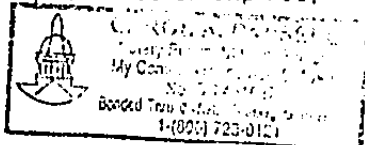
