ARTICLE I - NAME

The name of this corporation is COLD AIR TECHNOLOGIES, INC. and its principal place of business is 16790 West Pleasure Drive, Loxahatchee, Florida 33470.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business within the State of Florida.

ARTICLE IV - BOARD OF DIRECTORS

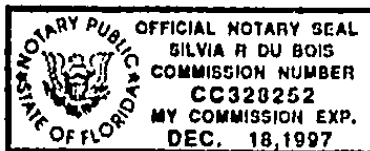
