ARTICLES OF INCORPORAGION OF BEEN THERE DONE THAT, INC

The undersigned hereby associate themselves together for the purpose of becoming a body corporate under the laws of the State of Florida and do hereby certify, make, subscribe, scknowledge, and file in the Office of the Department of State, this Certificate:

- 1. The name of the corporation shall be: BEEN THERE DONE THAT, INC
