The undersigned, in order to form a corporation for the purposes stated below, under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation is:

ARTICLE II. PURPOSE

The general nature of the business to be transacted by this corporation is as follows: **Video Production Services**

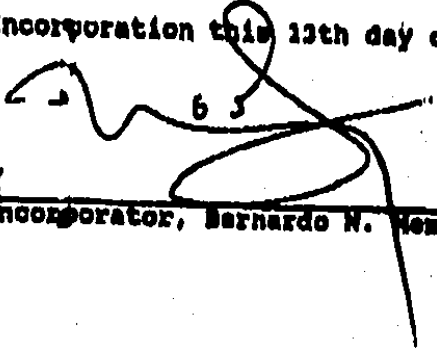
