INDEMNIFICATION**

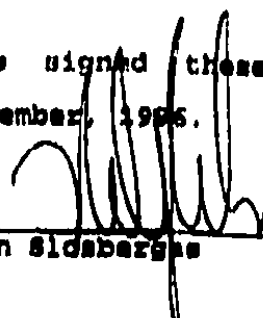
