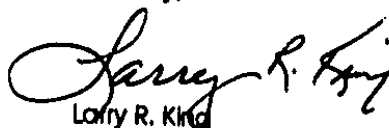

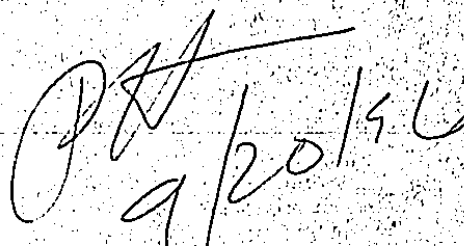

**ARTICLES OF INCORPORATION
OF

ARTICLE I-NAME

The name of this corporation is LaMar Land Co., Inc.

ARTICLE II-DURATION

This corporation shall exist perpetually, commencing on September 15, 1996.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the State of Florida.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 500 shares of par value common stock.

ARTICLE V-PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE IX-BY-LAWS

The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X-INDEMNIFICATION

The price and terms of which and the time within which such shares may be offered and sold shall be further specified in the By-Laws of this corporation.

ARTICLE XIII-TAX ARTICLE

It is the intention of this charter that the directors shall sell the capital stock of this corporation in accordance with the conditions of Section 1242-1244, inclusive of the Internal Revenue code.
