ARTICLES OF INCORPORATION

The undersigned, incorporator, for the purpose of forming a corporation under the Fierida Business Corporation Act, Chapter 607 of the Fierida Statutes, hereby adopts the following Articles, of incorporation:

ARTICLES I: NAME OF THE CORPORATION
