

ARTICLES OF INCORPORATION OF HOME DEPOT KITCHEN DESIGN, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME. KITCHEN DESIGN, INC.
