ARTICLES OF INCORPORATION OF BEST DISCOUNT JEWELERS & GIFTS, INC.

The undersigned subscriber to these articles of incorporation, being a flatural person and competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME
