ARTICLES OF INCORPORATION

OF

FIX IT RIGHT AUTO REPAIR PAINT & BODY SHOP, INC.

ARTICLE I - NAME

The name of this corporation is FIX IT RIGHT AUTO REPAIR PAINT & BODY SHOP, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing at the time of filing of the Articles of Incorporation with the Department of State.

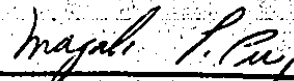

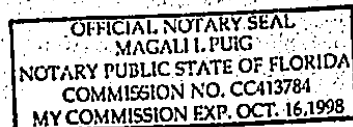
