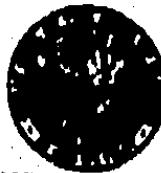

ARTICLE I. NAME

The name of the corporation is WILLIAMS FINANCIAL SERVICES, INC.

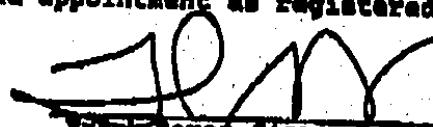

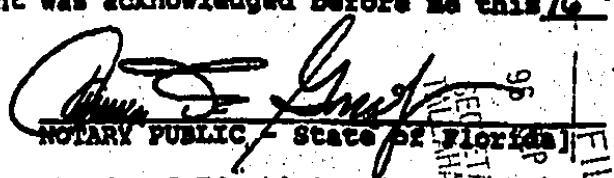

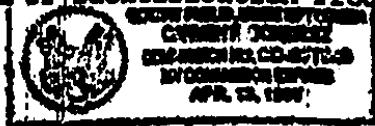
