ARTICLE ONE

The name of the corporation is **MICROTECH COMPUTER SERVICES, INC.**



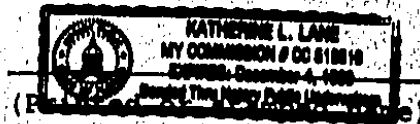


