The undersigned hereby execute(s) and acknowledges the incorporation in order to organize and incorporate a business for profit.

ARTICLE I - NAME

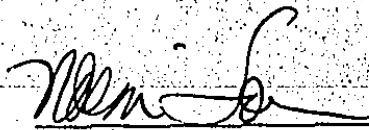

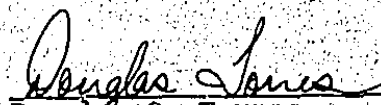
