**ARTICLES OF INCORPORATION  
OF**

**HEALTH AND LONGEVITY CLUB, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

**ARTICLE I**  
Name

The name of the Corporation is Health and Longevity Club, Inc.

**ARTICLE II**  
Duration

The term of existence of the Corporation is perpetual.

**ARTICLE III**  
Nature of Business

The nature of the business to be conducted by the Corporation is:

1. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act;
2. To engage in the sale and promotion of vitamins and nutritional products and custom vitamin programs to the general public; and
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV**  
**Capital Stock**

The aggregate number of shares which the Corporation has authority to issue is Ten Million (10,000,000), all of which shall be common stock having a par value of One Cent (\$.01) per share.

**ARTICLE V**  
**Preemptive Rights Granted**

Each shareholder of any class of stock of this Corporation shall be entitled to full preemptive rights to purchase unissued or treasury stock of the Corporation and any securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury stock.

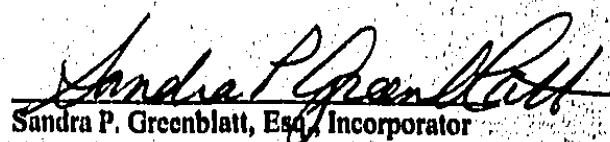
### **Reimbursement for Organizational and Certain Other Preincorporation Expenses; Adoption of Contracts**

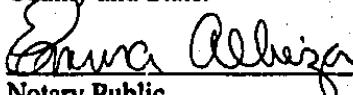
