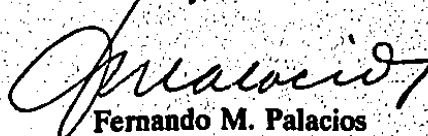

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE I - NAME

The name of this corporation is **The Group JAM-CAN, Corp.**, with its principal office located at 1509 Hedrick Drive, Melbourne, Florida 32901.

ARTICLE II - DURATION

The term of existence of the corporation is perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares that the corporation has authority to issue is 1000 with no par value.

ARTICLE V - PREEMPTIVE RIGHTS

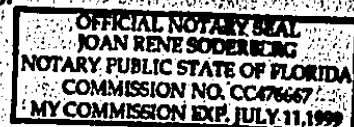

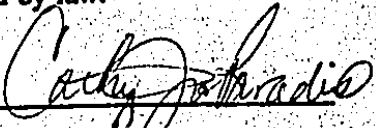
