ARTICLES OF INCORPORATION
OF

SAN FRANCISCO TRADING CO., INC.

ARTICLE I - NAME

The name of this corporation is:

San Francisco Trading Co., Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - GENERAL NATURE

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.
