The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following articles of incorporation:

ARTICLE ONE: NAME AND ADDRESS

The name of the corporation is Dien & Cowart Enterprises, Inc. The principal address of the corporation is 1305 Woodbine Street, Clearwater, Florida.

ARTICLE TWO: DURATION

This corporation shall exist perpetually.

ARTICLE THREE: PURPOSE

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
