ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the laws of Floria, adopt the following Articles of Incorporation for such corporation.

Article II
This corporation is organized to do any and all lawful business

ARTICLE LIIT
The maximum number of shares of stock that this corporation is authorized to have out standing at any one time is 100 shares of common stock of the par value of .10 per share.


