ARTICLES OF INCORPORATION OF **GOLDEN CRAB CORPORATION**

The Undersigned does hereby apply for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges, duties, and immunities of a corporation for profit, under and pursuant to these-Articles of Incorporation.

The name of the Corporation is: GOLDEN CRAB CORPORATION.

ARTICLE II

That the general nature of the business and objects and purposes to be transacted and carried on are that this corporation may engage in any activity or business under the laws of the United States and this State.

ARTICLE III

That the total number of shares of capital stock which may be issued by this corporation is Ten Million Shares (10,000,000) shares as follows:

Three Million (3,000,000) shares of the capital stock shall be Class A Common stock with a par value of fifty cents (\$.50) per share. Holders of Class A Common stock are entitled to receive dividends at a fixed annual rate of twelve percent (12%), payable quarterly, or the applicable percentage of the Net Income of the corporation, payable quarterly, whichever is greater.
