This letter is in response to the second notice received by the above referenced corporation. We feel that we have reasonable cause to abatement of the additional filing fee of \$400.

The corporation has several reasons for the abatement of the additional fee:

- ☐ Corporation relies on a professional to direct him as to what his compliance responsibilities are. The officers will do not expedite any taxes or fees unless directed by the professional
- ☐ The business was having problems with mail being stolen out of his mailbox. A pool hall and lounge opened in the fall of 1999 next door and has had difficulty and problems with vandalism, Lost mail and graffiti.

We cannot find where the original annual report renewal was received. The business has lost some important mail due to the vandalism and mail theft. Also, the business relies on his professional to inform him of his annual obligations and when specific forms are due.

We feel that due to the problems with mail theft and vandalism and the reliance of a professional is reasonable cause for the abatement of the additional fee of \$400.
