ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - DURATION

This corporation is to exist perpetually and it shall commence its existence as of the date of subscription and acknowledgement, provided such date is within five (5) days from the date of filing, otherwise, on the date of filing.
