

RICHARD A. HOWARD, P.A.**

The undersigned, for the purpose of forming a corporation under the Florida Professional Association Act, hereby adopt the following Article of Incorporation:

**ARTICLE 1 - NAME**

The name of the corporation shall be: Richard A. Howard, P.A.

**ARTICLE 2 - PLACE OF BUSINESS**
