PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION  
ACT THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT

FIRST: The name of the corporation is WORLD MORTGAGE CORPORATION

SECOND: The Articles of Incorporation of this corporation are amended by changing the article numbered "THIRD"(III) so that, as amended, said article shall read as follows:

THIRD: The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is three thousand (3,000) shares of common stock having one dollar (\$1.00) par value per share.

THIRD: The amendment to the Articles of Incorporation of the corporation set forth above was adopted on the 14th day of April, 1997.

FOURTH: The amendment was approved by the shareholders. The number of votes cast for the amendment by the shareholders was sufficient for approval.
