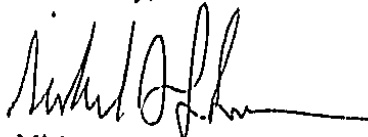

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a qualified person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is JON ANDERSON PRINTING, INC.

ARTICLE II

The Corporation shall have a perpetual existence. The Corporation shall commence existence five (5) business days before the filing of these articles by the Secretary of State of the State of Florida.
