ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is THE SYDNEY ROSE GROUP, INC.

ARTICLE II

The street address of the principal office of the Corporation is Suite 169, 18459 Pines Boulevard, Pembroke Pines, Florida 33029.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares.
