# ARTICLES OF INCORPORATION CHIMAERA, INC.

The undersigned, as sole subscriber to these Articles of Incorporation, being a natural person, competent to contract and to Ş rondor services under the Laws of the State of Florida, horeby presents and adopts these Articles of Incorporation of a corporation under the Florida Business Corporation Act, and other laws of the State of Florida.

### ARTICLE I

The name of the corporation is "CHIMAERA, INC.", whose primary address is 1720 Jones Road, Melbourne, Florida, 32934 and whose mailing address is 1720 Jones Road, Melbourne, Florida, 32934.

# ARTICLE II

The term of existence of this corporation shall be perpetual.

# ARTICLE III

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

### ARTICLE XI

Except as otherwise provided by Law, the entire voting power for the election of Directors shall be vested exclusively in the shareholders of the outstanding common shares. regard to questions of the election and direct appointment of officers, appointment of employees and the issuance of dividends. Such regulations or restrictive provisions shall not affect the rights of parties without actual notice thereof unless notice of the oximionco of such provisions shall be plainly written upon the cordificate evidencing the ownership of such shares.

# ARTICLE XII

The shareholders of the Corporation shall have the power to include in the By-laws, adopted by a sixty percent (60%) majority of the stockholders of the Corporation, any regulations or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding shares of the Corporation by any of its shareholders, or in the event of the death, termination, or resignation of any of its shareholders who may also be Directors or Officers of the Corporation. The manner and form, as well as the relevant terms, conditions, and details thereof, shall be determined by the shareholders of the Corporation provided, however, that such regulatory or restrictive provisions shall be plainly written upon the certificate evidencing the ownership of such shares.
