

ARTICLE I--NAME

The name of this corporation is ANNAJO, Inc.

ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on upon the filing of these Articles.

ARTICLE III--PURPOSE

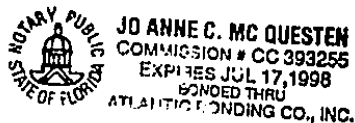


