**ARTICLES OF INCORPORATION  
OF

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. NAME.** The name of this corporation shall be:

**FORTY SHADES OF GREEN COMPANY**

**ARTICLE II. PRINCIPAL OFFICE:** The principal place of business or mailing address of this corporation shall be:

**3300 University Drive, Suite 601, Coral Springs, FL 33065**

**ARTICLE III. CAPITAL STOCK.** The aggregate number of shares of stock this corporation is authorized outstanding at any one time is: One Thousand (1,000) Shares, all of one class, common stock, at One (\$1.00) Dollar par value.

**ARTICLE IV. TERM OF EXISTENCE.** This corporation is to exist perpetually.

**ARTICLE V. PREEMPTIVE RIGHTS.** Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind, or series of stock in this corporation that may from time to time be issued, (whether or not presently authorized), including shares from the Treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding exclusive of Treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

**ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT.** The name and address of the initial registered agent and office of this corporation is as follows:

**ARTICLE VIII. INITIAL BOARD OF DIRECTORS.** This corporation shall have two (2) director(s) initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of the corporation in the manner provided by law but shall never be less than one (1).

**ARTICLE IX. PURPOSE.** The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Chapter 607, the "Florida Business Corporation Act" of the State of Florida. Further, the business purposes of this corporation are to acquire, dispose of, hold, import, export, lease, manufacture, grow, repair and restore for itself and others, as Principal, Agent, Broker, Plant Broker, Nurseryman, and/or Stock Dealer, all plants, trees, shrubs, vines, bulbs, cuttings, grafts, scions, or buds grown or kept for or capable of propagation or distribution, forage and cereal plants, and all other plants and plant parts, including cuttings, fruit, vegetables, roots, seeds, and all other landscaping material, as well as all devices, appliances, ancillary landscaping materials or components, necessary or useful in the production of "nursery stock", plants and plant products, all pursuant to Chapter 581, Florida Statutes (1995) and the exemptions set forth under §481.329, Florida Statutes (1995).

**ARTICLE X.**

**NOTICE.** All notices required by Chapter 607, Florida Statutes, including notice to directors and shareholders, must be in writing unless oral notice is authorized in the bylaws.

**ARTICLE XI.**

**SHARES WITHOUT CERTIFICATES.** The board of directors may authorize issuance of all or any portion of the corporation's shares without certificates unless the bylaws provide otherwise.

**ARTICLE XII.**

**AMENDMENT OF ARTICLES.** This corporation may amend its Articles of Incorporation at any time to add or change a provision that is required or permitted in the Articles of Incorporation or to delete a provision not required in the Articles of Incorporation. This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation. The power to adopt, alter, amend or repeal the Articles of Incorporation of this corporation shall be vested in the board of directors and approved by a majority of the shareholders entitled to vote as more specifically set forth in §§607.1002 and 607.1003, Florida Statutes.

**ARTICLE XIII.**

**CUMULATIVE VOTING.** In any election of directors by the shareholders, each shareholder of record shall have the right to cumulate his shares and to give one (1) candidate as many votes as the number of directors to be elected multiplied by the number of shares equals, or to distribute them on the same principle among as many candidates as he sees fit, provided however, that notice shall be given by any shareholder to the President or a Vice President of the corporation not less than twenty-four (24) hours before the time fixed for the holding of the meeting for the election of directors that he intends to cumulate his votes at such election. This right to vote cumulatively shall not be further restricted or qualified by any provision in the bylaws of the corporation.


**ARTICLE XIV.**

**INDEMNIFICATION.** The corporation may be empowered to indemnify any officer or director, or any former officer or director in the manner set out and provided for pursuant to the provision of §607.0850, Florida Statutes.




