The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do boroby adopt the following Articles of Incorporation:

### Article 1

### NAME OF CORPORATION:

### ARTICLE 3

#### **PURPOSE:**

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. To develop, own, hold, rent, lease, manage, encumber, improve, exchange, buy and sell real property, collect rents, and do a general real estate business and in gneral to have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects above mentioned.

### ARTICLE 4

### CAPITAL STOCK:

The aggregate number of shares which the Corporation is authorized to issue is 500 shares of common stock. Such shares shall be of a single class and shall have a par value of ONE DOLLAR per share.

### ARTICLE 5

# INITIAL REGISTERED OFFICE AND AGENT:

The street address of the initial Registered Office of the Corporation is 11533 South Dixie Highway, Miami, Florida 33156, and the name of its initial Registered Agent at that address is MARTIN LEVINSON. The address of the Principal Office is the same as the Registered Office.

### ARTICLE 6
