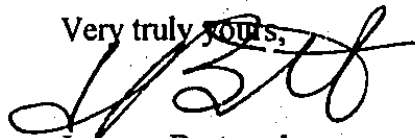

ARTICLES OF INCORPORATION
of

The Undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the state of Florida.

ARTICLE I. - NAME

The name of this corporation is Scooters To Go, Inc.

ARTICLE II. - NATURE OF BUSINESS

The Corporation is organized for the purpose of engaging in any activities of business permitted under the laws of the United States and of the State of Florida.

ARTICLE III. - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One-Thousand (1000) shares of common stock with One-Dollar (1.00) Par Value per share. The consideration to be paid for each share shall be fixed by the board of directors. The stock so issued shall be fully paid and non-assessable.

ARTICLE IV. - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is One-thousand (1000.00) Dollars.

ARTICLE V. - TERM OF EXISTENCE

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE VI. - PRINCIPAL OFFICE

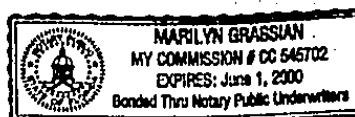

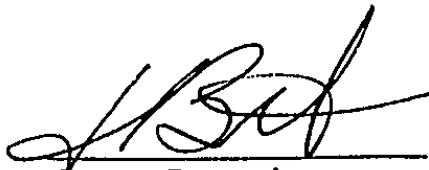
