ARTICLES OF INCORPORATION

OF

M Z CONSTRUCTION, INC.



THE UNDERSIGNED, acting as incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE 1

The name of the corporation shall be: M Z CONSTRUCTION, INC.

ARTICLE II

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE III

The principal place of business and mailing address of the corporation shall be: 8231 SW 9th Court, North Lauderdale, Florida 33068.

ARTICLE IV

The Corporation shall have the authority to issue 5,000 shares of the common stock, all of one class, at one dollar par value.

ARTICLE V

Preemptive rights shall be as follows:

The shareholders shall have the preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such shares of stock as may be issued from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of the common stock held by the holder of common stock currently authorized and issued.

ARTICLE IX

Unless otherwise provided in the corporation's Bylaws, no shares of the capital stock of this corporation may be transferred without the prior approval of the corporation's Board of Directors.

ARTICLE X

The corporation shall indemnify its officers, directors and authorized agents for all liabilities incurred directly, indirectly or incidentally to services performed for the corporation, to the fullest extent permitted under Florida law existing now or hereinafter enacted.
