

ARTICLES OF INCORPORATION

RAINDANCE DIVERSIFIED CORPORATION

ARTICLE I - NAME

The name of this corporation is RAINDANCE DIVERSIFIED CORPORATION.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- A. The manufacture and sale, at wholesale or retail, of metal cases and containers used in the music industry and otherwise.
- B. The manufacture and sale, at wholesale or retail, of Adirondack chairs.
- C. Any proper business purpose which is reasonably related to the primary purposes of the corporation as set forth above.
- D. Transaction of any other lawful business, whether similar or dissimilar to the primary purposes described above, for which corporations may be incorporated under Chapter 607, Florida Statutes.
