### ARTICLES OF INCORPORATION POF HERNANDEZ AND ASSOCIATES, INC.

# SSSP 23 PH H I7

#### ARTICLE I

NAME: The name of this corporation is: HERNANDEZ & ASSOCIATES, INC.

#### ARTICLE II

**DURATION:** This corporation shall have perpetual existence.

#### ARTICLE III

**PURPOSE:** This corporation is organized for the following purposes: To engage in the providing of financial and insurance services, and to acquire, own, hold, manage, mortgage, improve, lease, sell, exchange, transfer and otherwise deal with real personal property wherever situate, and to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
