Articles of Incorporation of Robert C. Kain, P.A.

The undersigned, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

Article 1

CORPORATE NAME

The name of this Corporation shall be: Robert C. Kain, P.A.

Article II

NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be:

- A. To engage in every aspect and phase of the practice of law rendering the same professional services to the public that attorneys, duly licensed under the laws of the State of Florida, are authorized to render; provided, however, that such professional services shall be rendered only through officers, employees, and agents of this Corporation who are duly licensed to practice law under the laws of the State of Florida.
- B. To invest and reinvest the funds of this Corporation in real estate, mortgages, stocks, bonds or any other types of investment within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services in the practice of law.
- C. To do each and every thing necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this Corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this Corporation; and, in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuits necessary or incidental to the accomplishment or furtherance of such purposes or objects of this Corporation.

D. To conduct and transact any business lawfully authorized and not prohibited by Chapter 621, Florida Statutes, as the same may be amended from time to time.

Article III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time shall be 1,000 shares of common stock having a par value of \$.001 per share.

This Corporation shall only issue its common stock to an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the Corporation was incorporated. Shareholders of this Corporation shall not enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

Article IV

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

Article V

REGISTERED AGENT AND INITIAL REGISTERED OFFICE IN FLORIDA

This Corporation shall have one (1) Director initially.
