ARTICLES OF INCORPORATION
OF
G. & L. ARCHITECTURAL SERVICES, INC.

The undersigned subscriber being a natural person competent of contract hereby files the following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

NAME. The name of the corporation shall be
G. & L. ARCHITECTURAL SERVICES, INC.

ARTICLE II

DURATION. This corporation shall exist perpetually.

ARTICLE III

PURPOSE. The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purposes and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

ARTICLE IV

CAPITAL STOCK. This corporation is authorized to issue 100 shares at \$1.00 par value stock. The consideration to be paid for each share shall be fixed by the Board of Directors, but in no event shall be less than One Dollar (\$1.00).

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of the corporation is 10420 S. E. Jupiter Narrows Drive, Hobe Sound, Florida 33455 and the registered agent is Gregory M. Bischof.

ARTICLE VI

PREEMPTIVE RIGHTS. Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata shares thereof (as nearly as may be done without issuance of fractional shares) at the prices at which it is offered to others.

ARTICLE VII

INITIAL BOARD OF DIRECTORS. This corporation shall have ONE (1) director initially. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one. The name and address of the initial director of the corporation is as follows; Gregory M. Bischof, 10420 S. E. Jupiter Narrows Drive, Hobe Sound, Florida 33455.

ARTICLE VIII

INCORPORATORS. The name and address of the person signing these By-Laws is Gregory M. Bischof, 10420 S. E. Jupiter Narrows Drive, Hobe Sound, Florida 33455.

ARTICLE IX

BY-LAWS. The power to adopt, alter or repeal By-Laws shall be vested in the Board of Directors and shareholders.

ARTICLE X

AMENDMENT. These Articles may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders and approved by the vote of the shareholders owning at least a majority of the issued and outstanding shares entitled to vote thereon; alternatively, these Articles may be amended if all the Directors and all of the shareholders of this corporation shall sign a written statement manifesting their intention and consent that a certain amendment to these Article of Incorporation be enacted, in which case such amendment shall be fully effective for all purposes when filed with the Secretary of State, as required by law.
