ARTICLES OF INCORPORATION OF G. & L. ARCHITECTURAL SERVICES, INC.

The undersigned subscriber being a natural person commpetent of contract hereby files the following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privelages and immunities of a corporation for profit.

ARTICLE I

NAME. The name of the corporation shall be G. & L. ARCHITECTURAL SERVICES. INC.

ARTICLE II

QURATION. This corporation shall exist perpetually.

ARTICLE III

<u>PURPOSE</u>. The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purposes and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

ARTICLE IV

CAPITAL STOCK. This corporation is authorized to issue 100 shares at \$1.00 par value stock. The consideration to be paid for each share shall be fixed by the Board of Directors, but in no event shall be less than One Dollar (\$1.00).

ARTICLE V
