ARTICLES OF INCORPORATION OF AHANOTU ENTERPRISES, INC.

The undersigned, acting as the sole incorporator does Reraby desire to form a corporation for profit pursuant to the Florida Business Corporation Act and does hereby adopt the following Articles of Incorporation:

ARTICLE I-NAME OF CORPORATION

The name of the corporation shall be AHANOTU ENTERPRISES, INC.

ARTICLE II-TERM OF EXISTENCE

The corporation shall commence its corporate existence upon the execution of these Articles of Incorporation and shall exist perpetually.

ARTICLE III-GENERAL PURPOSES
