ARTICLES OF INCORPORATION
OF
ROGER'S PLUMBING SERVICE, INC.

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act for the purpose of an incorporation under the laws of the State of Florida, adopt the following Articles of Incorporation for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I. NAME

The name of this corporation shall be ROGER'S PLUMBING SERVICE, INC.

ARTICLE II. GENERAL NATURE OF BUSINESS

The general nature of business and the objects and purposes, proposed to be transacted by this corporation, is any activity or business permitted under the laws of the State of Florida, and the laws of the United States of America.

ARTICLE III. CAPITAL STOCK

The amount of capital stock for this corporation shall be 100 shares of par value of One Dollar (\$1.00) per share.

ARTICLE IV. PRINCIPAL PLACE OF BUSINESS

The principal place of business of said corporation shall be 219 N.E. 15th Terrace, Ocala, Marion County, Florida, with the privilege of having branch offices at other places within and without the State of Florida.






ARTICLE X. ACKNOWLEDGMENT AND ACCEPTANCE
