ARTICLES OF INCORPORATION
OF
NUNES & COMPANY BUSINESS ACCOUNTS, INC.

The undersigned, acting as incorporator of NUNES & COMPANY BUSINESS ACCOUNTS, INC., a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the information, liabilities, rights, powers, immunities of a corporation for profit, and do hereby certify:

ARTICLE I

The name of the Corporation is NUNES & COMPANY, BUSINESS ACCOUNTS, INC.

ARTICLE II

The Corporation shall have perpetual existence.

ARTICLE III

The general purpose for which the corporation is organized is:

- 1. To engage in the business of managing NUNES & COMPANY BUSINESS ACCOUNTS, INC. affairs either on its own behalf as principal, or as importer and/or exporter, or as a jobber, or on commission, or as a broker, or as a commercial and general agent and factor for any person, partnership, association, or corporation to purchase or otherwise acquire, own, mortgage, pledge, charter, lease, sell, assign and transfer, or otherwise dispose of, and deal in and with either at a wholesale, or retail and machinery, implements, tools, appliances, supplies, and other goods, wears and merchandise of all kinds pertaining to the operation of a management office permitted under the laws of the United States of America, or of this State.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage into any other trade or business which can, in the opinion or the shareholders or the Corporation, be advantageously carried on in sonnection with and auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLES IV

The aggregate number of shares which the corporation is authorized to issue is FIVE HUNDRED (500). Such shares shall be of single class and shall have a par value of ONE DOLLAR (1.00) per share.

ARTICLE V

Preemptive Rights Designation: Each shareholder of the Corporation shall have the right to purchase, subscribe for or receive a right or rights to purchase, subscribe for at par value thereof, pro-rated portion or any stock or any class that the corporation may issue or sell, whether or not exchangeable for any stock of the corporation or any class or classes and whether or not of unissued shares authorized by the Articles of Incorporation originally filed, or by any amendment thereof or out of shares of stock of the corporation acquired by it after the issuance thereof, and whether assued for sach, personal property, real property, or leases thereof, of any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation or any class or classes or to which is attached or pertinent any warrant or warrants or other instruments or instrument conferring on the holder the right to subscribe for or purchase from the corporation any share of its stock of any class or classes.

ARTICLE VI

The street address of the initial registered agent of the Corporation and the street address of the Corporation is 3917 N. Andrews Avenue, Fort Lauderdale, Florida 33309; and the name of the initial registered agent at such address is DAVID S. NUNES. The principal office address shall be the same as the registered office address.

ARTICLE VII
